Officials at Sl. No. (iv), (vi),(viii), and (ix) will be on probation for a period of one year from the date of assumption of charge of the post of Assistant Director (OL).

3. पदोन्नति के उपरोक्त आदेश को इसकी प्राप्ति की तारीख से 15 दिन की अवधि में सतर्कता क्लियरेंस की शर्त पर अमल में लाया जाना चाहिए।

The above order of promotion is to be effected within a period of 15 days from the date of issue thereof, subject to vigilance clearance.

4. चूंकि उपरोक्त क्रमांक (ii), (v) (vii) (x) and (xi) के पदाधिकारियों का स्थानांतरण उनके स्वयं के अनुरोध पर किया गया है, इसलिए वे पऊवि के दिनांक 20/8/2018 के कार्यालय ज्ञापन संख्या क्रमांक 28/1/2017-CC/10594 के अनुसार स्थानांतरण यात्रा भत्ता, कार्यारंभ समय आदि के लिए पात्र नहीं हैं।

The transfers of the officers at Sl. No. (ii), (v) (vii) (x) and (xi) above are on personal interest and hence they will not be eligible for transfer T.A., Joining Time etc., in accordance with DAE O.M. 28/1/2017-CC/10594 dated 20/8/2018.

Further, Officers at Sr. No.(i) and (iii) transferred on rotational basis outside their present station may be relieved latest by 15.04.2019, failing which they will stand relieved/deemed to be relieved from the next working day. If the officers do not report after relieving/deemed relieving, they will be treated as absenting from duty unauthorisedly and will be liable for disciplinary action besides non-drawal of salary and allowances.
