- (vi) Shri R. Umesh , Security Officer, AMD, Bangalore is transferred in the same capacity and posted to DCS&EM, Mumbai vice Shri V.P. Sawant transferred.
- (vii) Shri Gautam Das, Assistant Security Officer/A ,VECC, Kolkata is promoted to the grade of Security Officer (Level 8 of Pay Matrix) and posted to DCS&EM, Mumbai vice Shri M.S. Gophane retired.

2. उपरोक्त क्रमांक (vii) के कर्मचारी सुरक्षा अधिकारी के पद पर कार्यग्रहण की तारीख से एक वर्ष की अवधि हेतु परिवीक्षा पर रहेंगे।

Official at Sl. No. (vii) will be on probation for a period of one year from the date of assumption of charge of the post of Security Officer.

4. चूंकि उपरोक्त क्रमांक (iii) के पदाधिकारि का स्थानान्तरण उनके स्वयं के अनुरोध पर किया गया है, इसलिए वे पऊवि के दिनांक 20/8/2018 के कार्यालय जापन संख्या क्रमांक 28/1/2017-CC/10594 के अनुसार स्थानान्तरण यात्रा भत्ता, कार्यारंभ समय आदि के लिए पात्र नहीं हैं।

The transfer of the officer at Sl. No. (iii) is on personal interest and hence he will not be eligible for transfer T.A., Joining Time etc., in accordance with DAE O.M. 28/1/2017-CC/10594 dated 20/8/2018.

5. Further, Officers at Sr. No.(i),(ii), (iv), (v) and (vi) transferred on rotational basis outside their present station may be relieved latest by 22.07.2019, failing which they will stand relieved/deemed to be relieved from the next working day. If the officers do not report after relieving/deemed relieving, they will be treated as absenting from duty unauthorisedly and will be liable for disciplinary action besides non-drawal of salary and allowances.

6. If the transferred officers wish to avail any leave after the above-said date of relief, they have to first report to the unit to which they have been transferred and the leave will have to be invariably sanctioned by the leave sanctioning authority of the unit.
