
Dear Shri Vyas,



This is regarding filling up of one vacant post of Scientist 'G' (level 14) on deputation basis in the Science and Engineering Research Board (SERB), New Delhi.


2. The Science and Engineering Research Board (SERB) was established as a statutory body through an Act of Parliament, namely, the Science and Engineering Research Board Act, 2008. The Board, chaired by Secretary, Department of Science and Technology (DST), comprises of 16 members including six Secretaries to the Government of India, Chief Executive Officer of NITI Aayog and other independent members mainly from the scientific community nominated by the Government. The mandate of SERB, *inter-alia*, is to serve as a premier multi-disciplinary research funding agency for planning, promoting and funding basic research in the emerging areas of science and engineering. The Board, since its operationalization in November 2011, has taken significant decisions on R&D management.

3. SERB has proposed to fill up one vacant post of Scientist 'G' (level-14 in pay matrix Rs.144200-218200) on deputation basis. A brief advertisement has already been given in the Employment News dated 27<sup>th</sup> March-02 April, 2021.
