SINP is looking for a **DEPUTY CONTROLLER OF ACCOUNTS (DCA)** as per details given below.

The post will be filled up on deputation basis for a period of three years from amongst officers working in the central government / state government / autonomous bodies / PSUs/ Universities etc.

The selected candidate will be entitled to draw D.A, H.R.A, and other allowances as admissible to the employees of this Institute and DAE/GOI guidelines in force from time to time. The deputationist will be eligible to draw deputation duty allowance and their terms of deputation will be settled with the lending department as per the DoPT's extant orders on this issue.

Essential Qualifications:

5 (five) years of service at Level-9/10 in the same stream with APAR score of 8 and above in each of the last five years.

Desirable Qualifications: MBA (Specialization in Financial Management).

Working in a responsible position in a government / central autonomous / reputed private institution in Accounts department, covering planning / preparation of Plan & Budget Estimates, management of funds, financial accounting, preparation of final accounts and various statements of accounts & taxation etc.

Good knowledge of GOI rules, regulations and procedure and well versed with the usage of computers for the preparation of relevant documents related to his field of work

Age Limit: 50 years as on the closing date of receiving applications. Relaxation of age limit if any as per GOI rules.

Job Description: The selected person will have the overall responsibility of running a smooth and efficient Accounts Department under the supervision of the Registrar of the Institute.

Selection Procedure: Appointment will be made on the recommendations of the Selection Committee duly constituted for this purpose. The shortlisted applicants will be required to appear for a **written test** at SINP, Kolkata on a given date. The candidates qualifying the written test will be asked to appear for personal interview of selection committee on the next day. Based upon the performance of candidates in the written test and personal interview, the selection committee will recommend a panel to the appointing authority. The appointment will be made on approval of the competent authority.
