OFFICE MEMORANDUM

Subject: Introduction of Dress Allowance in lieu of Uniform Allowance, etc. payable to common categories of Group 'C' and erstwhile Group 'D' employees in the Department of Atomic Energy on implementation of 7th CPC recommendations – Regarding.


The undersigned is directed to state that in pursuance of the decisions conveyed by M/o Finance OM No.19051/1/2017-E.IV dated 02.08.2017 (**Annex-1**), D/o Personnel & Training, OM No.14/4/2015-JCA2 dated 31.08.2017 (**Annex-2**) and in supersession of the existing orders relating to admissibility of Uniform Allowance / Washing Allowance / Stitching Charges / Shoe Allowance, etc. payable to common categories of Group 'C' and erstwhile Group 'D' employees of the Department of Atomic Energy and its constituent units, who are supplied Uniform under DoPT orders and are required to wear them regularly shall be paid "Dress Allowance" at the rate of Rs.5000/- per year.

2. Accordingly, the Uniform Allowance / Washing Allowance / Stitching Charges / Shoe Allowance, etc. being paid as per DAE Note No.8/1/89-Gen/375 dated 02.06.1992, Note No.4/7/2011-SCS/9569 dated 25.07.2014 and DoPT OM No.14/1/2010-JCA2 dated 18.04.2011, circulated vide DAE endorsement No.2/1(5)/2009-SCS/4561 dated 28.04.2011 respectively stands subsumed in Dress Allowance.

3. These order shall cover only those employees (common categories) who are being issued uniform, based on the DoPT orders endorsed by this Department. Orders on uniforms issued by the Department of Atomic Energy for specific categories of employees such as Security / Fire Personnel etc. and protective clothing shall continue to be in force until further orders. Washing allowance and Stitching charges, if any granted to Security / Fire Personnel and protective clothing, etc. shall continue to be in force until further orders.

4. All other conditions stipulated by MoF and DoPT in their aforesaid OM dated 02.08.2017 and 31.08.2017 respectively shall be applicable and this order shall take effect from 1st July, 2017.

Subject: - Implementation of the recommendations of the Seventh Central Pay Commission. – Dress Allowance.

Consequent upon the decisions taken by the Government on the recommendations of the Seventh Central Pay Commission, in supersession of the existing orders relating to Uniform related Allowances viz. Clothing Allowance, Initial Equipment Allowance, Kit Maintenance Allowance, Robe Allowance, Robe Maintenance Allowance, Shoe Allowance, Uniform Allowance and Washing Allowance which have been subsumed in a single Dress Allowance, the President is pleased to decide the rates of Dress Allowance in r/o the following categories of Central Government employees as under:-

S.No.	Category of employee	Rate per annum (In Rs.)
1.	Special Protection Group (SPG) Operational Special Protection Group (SPG) Non-operational	27,800/- 21,225/-
2.	Officers of Army /IAF/ Navy/ CAPFs/CPOs RPF/RPSF/IPS/Coast Guard.	20,000/-
3.	MNS officers, Officers of DANIPS/ACP of Delhi Police/ other Union Territories.	15,000/-
4.	Executive staff of Customs, Central Excise and Narcotics Department (both in summer and summer-cum-winter), Indian Corporate Law Service (ICLS) Officers, Legal officers in NIA, Bureau of Immigration Personal (in Mumbai, Chennai, Delhi, Amritsar, Kolkatta and all check points of Bureau of Immigration) PBORs of Defence Services / CAPFs/RPF/Police Forces of Union Territories and Indian Coast Guard, Station Masters of Indian Railways.	10,000/-
5.	Other categories of staff who were supplied Uniforms and are required to wear them regularly like Trackmen, Running staff of Indian Railways, Staff Car Drivers, MTS, Canteen staff of Non-Statutory Departmental Canteens, etc.	5000/-
6.	Nurses	1800/- per month

2. Allowances related to maintenance, washing of Uniform are subsumed in Dress Allowance and will not be payable separately.
3. Further categories of staff who were earlier being provided Uniforms, will henceforth not be provided with Uniforms.
4. The amount of Dress Allowance shall be credited to the salary of employees directly once a year in the month of July.
5. This allowance covers only the basic uniform of the employees. Any special clothing like that provided at Siachen Glacier or inside submarine or fluorescent clothing provided to Trackmen or Indian Railways or to IB personnel posted at high altitudes will continue to be provided by the concerned Ministry as per existing norms.
6. Outfit Allowance, paid to Indian Foreign Service officers and employees will continue to be provided as before, is enhanced by 50%.
7. The rates of Dress Allowance will go up by 25% each time Dearness Allowance rises by 50%.
8. These orders shall take effect from 01st July, 2017.

9. Separate orders will be issued by Ministry of Defence, Ministry of Home Affairs, Ministry of Railways, Ministry of Health & Family Welfare, Ministry of Corporate Affairs, Ministry of External Affairs, Department of Revenue, Department of Personnel & Training and Cabinet Secretariat in respect of employees of these Ministries/ Departments.

10. In so far as the persons serving in the Indian Audit & Accounts Department are concerned, these orders issue in consultation with the Comptroller & Auditor General of India.



Subject: Implementation of recommendation of the Seventh Central Pay Commission on Dress Allowance – regarding.

The undersigned is directed to state that in pursuance of the decisions taken by the Government on the recommendations of Seventh Central Pay Commission, and in supersession of the existing orders relating to admissibility of Uniform Allowance/ Washing allowance/ Stitching Charges /Shoe allowance, etc to common categories of Group 'C' and erstwhile Group 'D' employees of various Ministries/Departments, including attached/ subordinate offices, who are supplied uniform and are required to wear them regularly, they shall be paid Dress Allowance at the rate of Rs. 5000/- per year.

2. The Uniform Allowance/Washing Allowance/Stitching Charges/Shoe Allowance, etc. have been subsumed in Dress Allowance.
3. The categories of Staff who were earlier being provided uniforms if any, shall henceforth not be provided with uniform.
4. Allowance related to maintenance and washing of uniform is subsumed under Dress Allowance, and will not be payable separately.
5. The amount of Dress Allowance shall be credited to the salary of employees directly once a year in the month of July.
6. The rate of Dress Allowance shall be, as mentioned in para-1 above, Rs.5000/- per year. The rate of Dress Allowance shall go up by 25% every time the Dearness Allowance rises by 50%.
7. This allowance covers only the basic uniform of the employees. Any special clothing will continue to be provided by the concerned Ministry as per existing norms.
8. This order shall take effect from 1st July, 2017.
