Officer at Sl. No. (iii) will be on probation for a period of two years from the date of assumption of charge of the post of Stores Officer.

The order of promotion in respect of officer at Sr. No. (iii) is to be effected within a period of 15 days from the date of issue thereof, subject to vigilance clearance

4. Further, Officers at Sr. No.(i) and (ii) may be relieved latest by 11.01.2021, failing which they will stand relieved/deemed to be relieved from the next working day. If the officers do not report after relieving/deemed relieving, they will be treated as absenting from duty unauthorisedly and will be liable for disciplinary action besides non-drawal of salary and allowances.
