Officials at Sl. No. (i), (iii), (v), (xvi), (xx), (xxii), (xxvii) and (xxix) will be on probation for a period of one year from the date of assumption of charge of the post of Assistant Personnel Officer.

3. पदोन्नति के उपरोक्त आदेश को इसकी प्राप्ति की तारीख से 15 दिन की अवधि में सतर्कता क्लियरेंस की शर्त पर अमल में लाया जाना चाहिए अन्यथा संबंधित अधिकारी विभाग की नीति के अनुसार पदोन्नति से एक वर्ष की अवधि के लिए वंचित हो जाएंगे।

The above order of promotion is to be effected within a period of 15 days from the date of receipt thereof, subject to vigilance clearance, failing which the officials concerned will stand debarred from promotion for a period of one year as per the policy of the Department.

4. चूंकि उपरोक्त क्रमांक (xxi) and (xxiii) के पदाधिकारियों का स्थानांतरण उनके स्वयं के अनुरोध पर किया गया है, इसलिए वे पऊवि के दिनांक 20/8/2018 के कार्यालय जापन संख्या क्रमांक 28/1/2017-CC/10594 के अनुसार स्थानांतरण यात्रा भत्ता, कार्यारंभ समय आदि के लिए पात्र नहीं हैं।

The transfers of the officers at Sl. No. (xxi) and (xxiii) above are on personal interest and hence they will not be eligible for transfer T.A., Joining Time etc., in accordance with DAE O.M. 28/1/2017-CC/10594 dated 20/8/2018.

5. Further, It may be noted that some of the officers who have completed 4 years residency period in a unit have not been considered for rotational transfer at present due to administrative exigencies and those officers will be considered for transfer during the next rotational transfer in the grade of APO.
